WETHERSFIELD, August 3, 2018 – To provide jobseekers in Eastern Connecticut with additional resources in their job search, the Connecticut Department of Labor is sponsoring a series of summer Micro Career Fairs at the Montville *American Job Center*. The next event, being held 11 a.m. to 2 p.m. on August 8, features four local employers. The center is located at 601 Norwich-New London Turnpike, Suite 1, Uncasville.

“Our Montville Micro Career Fairs have been very successful in connecting employers with jobseekers and we are pleased to host four companies at our next event,” said State Labor Commissioner Kurt Westby. “Our goal is to help employers find the employees they need, and to provide jobseekers with opportunities to meet one-on-one with local businesses.”
