**DECISION AND DISMISSAL OF COMPLAINTS**

On July 14, 2011, United Public Service Employees Union/Madison Buildings and Grounds Maintenance (the Union) filed a complaint with the Connecticut State Board of Labor Relations (the Labor Board) alleging that the Town of Madison (the Town) had committed practices prohibited by the Municipal Employee Relations Act (MERA or the Act). On July 20, 2011 the Town filed a complaint against the Union alleging that the Union had committed practices prohibited by the Act. The complaints were consolidated and after investigation, the Agent of the Labor Board recommended dismissal of the complaints. The Agent's recommendation was served upon the parties by certified mail. No written objection to the Agent's recommendation has been filed with the Board. Accordingly, pursuant to 7-471-24 of the Regulations of Connecticut State Agencies, the complaints are dismissed.

**ORDER**

Pursuant to the power vested in the Connecticut State Board of Labor Relations by the Municipal Employee Relations Act, it is hereby

**ORDERED** that the complaints filed herein be and the same hereby is, **DISMISSED**.
