**I. ACCEPTANCE OF MINUTES**

- D. Staffing:** General Counsel Frank Cassetta completed interviewing candidates for the Assistant General Counsel vacancy. A decision is pending.

## **III. AGENT'S REPORT**

New Board Member (former Agent) Katherine Foley delivered the Agent's report, stating that scheduling formal hearings before the Board is proceeding as usual. The total number of cases in fiscal year 2021-2022 is 293, which is down from fiscal year 2020-2021. The window period for representation petitions opened in January and July; more petitions were received in July than January. This may be attributable to Covid pandemic.

## **IV. NEW BUSINESS**

- A. Acting agent:** The Board unanimously voted to appoint Assistant Agent Jose' A. Santana be the Acting Board Agent/Director retroactive to July 1<sup>st</sup>.
- B. Clerical help:** Jose Santana and Sondra Ivory to determine whether additional part-time clerical help is needed.
- C. Assistant Agent vacancy:** Applicants have been interviewed for the vacant position. A decision is still pending.
