DECISION AND EXPANSION OF UNIT

Pursuant to the Agreement for Consent Election, dated October 2, 2015, an election by secret ballot was conducted on October 22, 2015 at Promfet Center, Connecticut, under the supervision of the Connecticut State Board of Labor Relations. The tally of ballots was as follows:

Copies of the Report Upon Secret Ballot were duly served upon all parties. No exceptions to the report or objections to the election were filed with the Board.

Since the parties have agreed that the unit is appropriate, the Board's approval of the action herein is not to be taken as a precedent as to what unit it would find appropriate in the absence of such an agreement.

Therefore, by virtue of and pursuant to the power vested in the Connecticut State Board of Labor Relations by the Municipal Employee Relations Act, it is hereby,

DETERMINED that the existing unit represented for the purposes of collective bargaining by Local 1303-339 of Council 4, AFSCME, AFL-CIO is expanded to include the Manager, Kitchen Assistant 1, Kitchen Assistant 11 and that said Local 1303-339 is the exclusive representative of all said employees for the purpose of collective bargaining with respect to wages, hours and other conditions of employment.
