Dear Members of the Dislocated Worker Unit:

The ShopRite of West Hartford will be permanently closing its store located at 46 Kane Street, West Hartford, CT, 06119. The closure has been prompted by the company's decision to discontinue the operation of business at that location.

This action is expected to result in the permanent elimination of approximately 132 employees at that location - 130 hourly and 2 salary positions. The company expects to begin eliminating positions on November 26 2019 2019 and will continue until the store is completely closed on November 26 2019.

Many of the hourly employees are represented by the United Food & Commercial Workers Unit, Local 371. The representative of this union is Thomas Wilkinson, President of Local 371. Mr. Wilkinson is located 290 Post Road W, Westport, CT 06880. It is the company's position that inter-store bumping rights do not exist with respect to the elimination of the represented positions.

Attached is a list of job titles, numbers affected within each job title, and the anticipated layoff date for the salaried and hourly workers. The company will ensure that employees will be paid all earned wages and applicable benefits at the time of their termination.
