In anticipation of the receipt of formal regulatory and shareholder approvals to merge People's United Bank with M&T Bank Corporation ("M&T"), notice is hereby given under the Worker Adjustment and Retraining Act. On or about October 1, 2021, M&T will begin this reduction in the State of Connecticut.

The attached spreadsheet includes the employment sites where the reductions will occur and the number of permanent terminations at each site.

The expected date of the first termination resulting from this contemplated action is October 1, 2021. This date may be postponed, as events develop. The total number of terminations identified above will be completed by approximately May 20, 2022.
